# Delegate Lyle C.

## Introduction

Hello Area 42,

My name is Lyle. I'm an alcoholic. I have the honor of serving Area 42 as your Panel 75 Delegate, serving on the Trustees Committee and the IC/RF Committee.

What a great experience I had at the 75th General Service Conference—it's an opportunity of a lifetime. I'm so grateful. Julie and I got to NYC a couple of days early and went to GSO. They have a regular Friday 11:00 a.m. meeting and a tour afterward. We signed up beforehand to let the staff know we were coming. Of course, they knew the Conference was starting Sunday and that lots of people would be joining. It was a great meeting and an even better tour of GSO. Saturday night, Conference members met for a meet and greet to get to know one another. We hung out, talked, and exchanged pins and other gifts in the spirit of love and unity.

# **Opening Session – Sunday**

Scott H., Chair of the General Service Board (GSB), opened the session at 8:34 a.m. and said he was looking around to blame someone for not starting on time—then realized it was his responsibility to begin. The first order of business was to approve a replacement for the Nova Scotia Area 82 Delegate, who could not attend. The Area 82 Alternate Delegate, Ann B., was submitted and approved by full vote. Roll call was next. I was very excited to be part of the Conference, among 137 members, and to say "here" when it was my turn. Bob W. was calling names and keeping it light, which helped kick off the 75th GSC. Karen C., the Delegate Chair, gave opening remarks: "The hours are long, but the pay is amazing—we get to stay sober." Keynote Address – Sister Judith, Class A Trustee:

"I am truly comfortable being at the bottom of the triangle because my role is to provide service, support, and love for everyone above me. I know my role and I am happy being here." She spoke about the theme of the Conference: "Working Together, Increasing Trust." Bob W., GSO Manager, started the review of *How the Conference Operates*, but we didn't get through all of it, so it was tabled for later. Bob was reading from a document that wasn't in our binder—which actually helped me feel more comfortable, because we all make mistakes. Welcome to AA! Then we broke into our assigned inventory groups. My group, J, was assigned Questions 3, 4, 8, and 16 from 10:00 a.m. to noon. We had open discussion with a Class B Trustee, a staff member, and the Delegates. During the Conference, we discussed what to do with the inventory results. You know, just like after Steps 4 and 5 come 6 through 12—there's a process. I'll include the inventory results on our website, when I get them. The Pacific Region Delegates met for lunch and discussed the next Pacific Regional Forum in 2028. Area 42 just hosted one in Las Vegas, and Area 09 (Mid-Southern California) is putting in a bid. The next Pacific Regional Forum is scheduled for San Diego, December 4–6, 2026. After lunch, we had

the first of three inventory report backs.

Some Inventory Committees' Notable Responses:

- Communication should be steady and ongoing throughout the year—not limited to just before and after the Conference.
- Are we overloading our trusted servants? It's important to focus on our priorities and maximize efficiency.
- Openness is critical; we must commit to being as transparent as possible.
- The need for strong communication came up time and again.

Bob resumed *How the Conference Operates* and we agreed to use the version from the Service Manual. Scott announced that Trustees Andie M. and Kevin P. would rotate off at the end of the Conference. Andie had planned to rotate off after completing her first 3-year commitment. After dinner, the Pacific Region Panel 75 Delegates presented their Area Highlights. When it was my turn, I was extremely nervous. Luckily, I had presented at PRAASA a few weeks before.

# **Conference Committee on Trustees (CCT)**

The Conference Committee on Trustees (CCT), my committee, met twice—once with the Trustees and Delegates to accept the Trustee report, and again with Delegates only to go over the agenda list. These two meetings were conducted virtually before the Conference.

Essentially, the Trustees Committee ensures that Trustees, Directors, and Appointed Committee Members meet the qualifications for their positions. Additionally, if there are concerns regarding any of these individuals, they are reviewed by the Trustees Committee. Each of the 11 primary committees meet in a room with 8 to 9 of us. The committee chair opens it up and starts to work on the agenda items. We go around the table as many times it takes to discuss the agenda item or whatever were working on in order to come to an informed group conscience. I talked about what my area, north and south thought. In order for the committee to recommend an item to the full conference, we have to reach substantial unanimity with in the committee.

We began by reviewing the slates of Class A and Class B Trustees and the officers of the General Service Board of Alcoholics Anonymous, A.A. World Services, and A.A. Grapevine. The CCT reviews these slates for disapproval, if any—we do not formally approve them. I was so honored to be able to read Julie's résumé for the first time and was asked about her in the Trustees Committee. Julie is awesome, and A.A. is lucky to have her. (Except for marrying me—she's very bright!) Julie is Area 42's new Non-Trustee Director on A.A.W.S. Marita made sure we sat together when the slates went to the full conference.

We reviewed about 100 résumés to determine if individuals were qualified. We had that many because the U.S. Trustee-at-Large was rotating, and eight trustees were rotating as well. The Pacific Region has a new U.S. TAL—Jennifer B. from Northern California Coastal Area 06. The Pacific Region is well represented.

## Other Agenda Items Discussed

Item E. Review the progress report on the pamphlet "Do You Think You're Different?" The committee recommended retiring the pamphlet. The lack of story submissions over a two-

year period was considered evidence that the Fellowship has emphasized other literature to address the question, "Do I belong in A.A.?" The committee discussed how the Fellowship had been asked for two years to submit stories from a variety of perspectives, but very few were received. Some of the submitted stories were incorporated into other pamphlets; no new ones had been accepted for this pamphlet. Based on this, the committee recommended retiring it. However, when the recommendation went to the full Conference, there were strong feelings expressed in favor of keeping the pamphlet, and it was sent back to the Trustees' Literature Committee for further review.

**Agenda G**: Request to include the Lasker Award text from A.A. Comes of Age in Appendix D of the Big Book:

The committee took no action. It considered the existing Lasker Award text in A.A. Comes of Age sufficient. Vote: 7–2.

**Agenda F:** Grievances about General Service Board Actions and Proposed Censure Methods: The committee reviewed the subcommittee report and accompanying proposals. After a thoughtful and robust discussion, it took no action. One of the four possible censure methods was connected to a proposed agenda item that did not come out of the Agenda committee (Harmony and Effectiveness Sharing Session). Without that item, the remaining proposals lacked sufficient impact. Under New Business: The committee recommended a proposal to send censure/reorganization motions directly to the CCT:

The committee recommended that motions to censure or reorganize the General Service Board be submitted directly to the Conference Committee on Trustees (for committee eyes only), rather than to the Trustees Nominating Committee. The rationale was that grievances should be considered by a neutral committee—not by the individuals potentially involved. This recommendation did not pass.

Discussion on the Proposed Agenda Item (PAI) Process:

The committee had a wide-ranging and thoughtful discussion about the current process of placing PAIs on the final General Service Conference agenda. The committee strongly agreed that the Fellowship, through its representative Delegates, should have more of a voice in determining which items are included.

Our committee asked Scott H. (GSB Chair) and Terry Bedient (Trustee Emeritus, new Treasurer) to answer a few questions. Our board treasurer stepped down just prior to the Conference. The Trustees' Nominating Committee did not have sufficient time to adequately vet a new Class A Trustee. Terry had previously served as our treasurer and later as our GSB Chair, which qualifies him as a Trustee Emeritus. The GSB recommended that Terry serve as Treasurer, but not as a Trustee. The Trustees Committee invited both to answer a few questions. Will Terry have a vote at the Conference? He will be able to vote only on the committees he serves on. He may not attend Forums; Scott or Bob W. will give financial reports at those events.

After lunch, we continued with more inventory report backs, which I will include on the Area 42 password-protected webpage.

## **Financial Presentation**

After dinner, the financial auditing firm we hired presented their audit report. A full version will be included in the 75<sup>th</sup> Final Conference Report. They rated us as having a good measure of financial health. They found that management and travel costs for 2024 decreased by \$1.2 million compared to the previous year. The auditors noted that management had listened to and acted upon last year's audit recommendations, taking responsibility for the stability of our financial position.

# Key points:

- Strong management
- Good financial metrics in the financial statements
- No finances were transferred inappropriately between the corporations all transfers followed stated policy

Kevin then stated our financial position is very good. Our pension plans are well funded, and we currently have just over 6 months of operating funds in our prudent reserve (though our target is 9 to 12 months).

The suggested contribution to cover program services is \$6.48 per person.

If just 1 in 10 members subscribed to the Grapevine app, the Grapevine would be self-supporting.

The Grapevine and La Viña will have a large presence at the International Convention in Vancouver with hopes to increase subscriptions.

Wednesday the Pacific Region had lunch again and voted for our US TAL candidate. I had the pleasure to talk about Area 42 Rhonda F. The votes were counted many times Candace from Idaho (Area 18) and Jennifer (Area 06) went to the hat and Jennifer came out. Jennifer came out of the hat a second time when we had the vote at the full Conference.

# Wednesday afternoon

After lunch, the work begins in earnest—we started voting on Agenda Items. Once they start coming in, things get very busy. When a committee makes a recommendation, the Conference has the opportunity to discuss, amend, or vote on it. There isn't enough time here to cover every item, but I will post detailed information on our Area 42 website and I'll discuss some of the voting soon.

# Conference Committee on International Conventions/Regional Forums (IC/RF)

The Conference Committee on International Conventions/Regional Forums (IC/RF) met twice—once with the Trustees and Delegates to accept the Trustee report, and once with Delegates only to go over the agenda list. The meetings were held virtually before the Conference.

We met again during dinner on Wednesday and during lunch on Thursday. Both sessions went well.

## **2025 International Convention Updates**

As of our meeting, over 31,000 people had registered for the 2025 International Convention. Based on current week-to-week trends, total attendance is projected to reach approximately 35,000. The break-even point is 32,500.

Reports included concerns about the cost of travel, accommodation, and border crossing—these

were cited as factors impacting attendance.

The Convention Consultant reported that they are not receiving enough responses to the accessibility survey. This survey has been distributed multiple times to registered attendees who indicated interest in accessible services. The lack of responses impacts our ability to estimate the need for scooters, wheelchair rentals, and shuttle services. Planning is currently based on the limited information available, though contingency plans are in place to scale up services if necessary.

# **Key Highlights and Preparations**

- Virtual Program Access:

For the first time, the 2025 International Convention will offer a Virtual Program Session Track. Enhanced communication began after May 9, 2025, to inform members unable to attend in person that they still have a way to participate in our 90th Anniversary celebration.

- \$35 for individuals
- Group pricing available on AA.org
- Online Registration:

This is the fifth International Convention to offer online registration. While it works well for most, some experienced issues logging in during the early days of registration. Communications have been sent out to help attendees prepare for the in-person experience in Vancouver.

- Flag Ceremony Broadcast:

The Friday night Flag Ceremony will not be streamed live. It will be recorded, edited to protect anonymity, and shared as a post-event broadcast.

- Program Guide:

The advance Program Guide has been mailed to all registrants, is available on GSO's website, and has been distributed through other communication channels. The program emphasizes A.A.'s Anonymity Traditions. Box 4-5-9 (Spring issue) includes the article "Countdown to Vancouver."

- Convention App:

A dedicated Convention app will launch in May 2025, available for download on mobile devices.

- Onsite Booths: Pacific Region will have a Hospitably Suite - Lisa I. will Chair and has more info.

The International Convention will include:

- An Anonymity Booth
- A "Carry the Message" pavilion with information booths from:
- Cooperation with the Professional Community (CPC)
- Corrections
- Grapevine/La Viña
- Public Information
- Accessibilities
- Treatment

#### **Committee Discussions**

- 2030 Declaration:

The committee reviewed a report on developing a new declaration for adoption at the 2030 International Convention. The committee fully supports the Trustees' IC/RF Committee's concept: a declaration reflecting our Third Legacy of Service and the Fellowship's group conscience, recognizing how individual voices and actions contribute to our collective wisdom.

- Flag Ceremony and Sovereign States:

The committee considered a request to include all sovereign states' flags in the Flag Ceremony. Consensus: explore this option further, including any cultural or logistical impacts.

The Trustees' IC/RF Committee was asked to gather input from indigenous communities and include a question in post-Convention surveys to determine how many attendees identify with First Nations sovereign states. A progress report is expected at the 2026 Conference.

- Regional Forum Improvements:

The committee reviewed the final report from the Subcommittee on Regional Forum Improvements. Appreciation was expressed for:

- Budget planning
- Live broadcast pilot
- Enhanced interpretation services
- Regional Forum RFI Forms:

The committee appreciated GSO's continued collaboration with areas and regions during planning. There was discussion about limiting the use of casino venues that allow smoking; many members disagreed with such restrictions.

- Encouraging Forum Participation:

The committee discussed strategies to attract first-time attendees to Regional and Local Forums. They appreciated previous efforts and suggested that GSO record a podcast episode featuring Regional Forums.

## A.A. International: World Service Meeting Highlights

All three presenters showcased the value of our World Service efforts. I especially appreciated Marita R.'s comments. When she began her service as Trustee-at-Large, there was one country on the World Zone map still colored blue—meaning A.A. had no presence there. That country was Guyana. Now, as she prepares to rotate out, Guyana is green. She shared the story of how one member made the connection to help that happen.

# **Discussion and Voting on Agenda Items**

Recommendations from committees that pass the full conference with substantial unanimity (2/3rds) become advisory actions. In other words, new policy.

## **Agenda Committee**

Agenda A: Theme for the 2026 General Service Conference: "Humility in Action"

• Vote: 125 - 8 - passed - I voted Yes

**Agenda D.** Discuss progress report on Conference Inventory.

The committee recommended that a Conference Inventory Implementation Committee with a composition similar to the makeup of the General Service Conference (delegates, trustees, nontrustee directors, and staff members from the General Service Office and AA Grapevine) be established by the General Service Board to identify and implement actionable items, based on the inventory report back sessions held at the 2025 General Service Conference. The committee requested that a planning committee report be brought back to the 2026 General Service Conference.

• Vote: 117–14 – passed – I voted Yes

**Agenda J.** Consider a proposed pilot for a Harmony and Effectiveness Session (New Item): Our Area voted 'No.' It did not come out of committee, so no vote was taken at the Conference.

#### **Finance Committee**

**Agenda G.** Consider a request to remove the phrase "A group may also decline to hear reports from a GSR at all" from page 10 in the A.A. Service Manual:

• Vote: 111–17 – passed – I voted Yes

New Business: The committee recommended that the General Service Board Quarterly Financial Report include supplemental reporting on current capital projects and current and future associated maintenance costs.

• Vote: 103–28 – passed – I voted Yes

The committee recommended pausing the retrofit of the General Service Office until the Trustees Finance & Budgetary Committee develops a plan to replenish the reserve fund to a minimum of nine months and bring back a progress report to the 76th General Service Conference.

**Proposed Agenda Item** (PAI) asked that GSO stop the renovation on the 11th floor. We discussed it for some time, weighing the pros and cons. However, contracts had already been signed, and stopping the project at this point would have caused both damage to A.A. and incurred thousands of dollars in fees.

• Vote: 22–105 – failed – I voted No

#### **Literature Committee**

**Agenda J.** Consider request to include the Twelve Concepts for World Service and the essays on the Concepts in the book Twelve Steps and Twelve Traditions:

- Committee recommended inclusion
- Vote: 69–61 in favor, but failed with simple majority I voted Yes

Agenda K. Consider request to update Living Sober:

• Vote: 94–37 – passed – I voted Yes

Agenda L. Discuss Plain Language Big Book (PLBB) review process:

 $\bullet$  Committee recommended that proposals to revise or rescind the PLBB be collected and deferred until the 77th GSC to allow for wider Fellowship input:  $\bullet$  Vote: 120-11-passed-I voted Yes

# **Report & Charter Committee**

**Agenda A3.** Consider a request to remove the word "woman" from the Concept Four essay:

- Committee recommended removal
- Vote: 108–20 passed I voted Yes

Agenda B. Consider a request to expand Article Three in the Conference Charter to protect the co-Founders' writings:

- Committee recommended classifying all AAWS and AA Grapevine literature written before 1971 as Recovery, Service, or Archival/Historical
- Recommended policy review and updates, with a progress report due at the 2026 GSC
- Vote: 109–20 passed I voted Yes

## **Policy/Admissions Committee**

**Agenda E.** Consider request that a supermajority of voting members be required to change or amend Founders' literature:

• Did not come out of committee

Agenda F. Consider request to develop guidelines for the roles and responsibilities of temporary replacement delegates:

- Committee recommended access to Onboard platform through year-end at discretion of the sitting Area delegate
- Vote: 118–13 passed I voted Yes

# **Public Information Committee**

Agenda B3: Consider a suggestion to develop new video Public Service Announcement (PSA).

The committee recommended that three videos produced by the General Service Board of Alcoholics Anonymous Australia ("Are you risking your job?" "Are you a danger to your family?" "Cham-pain") be adapted by AAWS for use on media platforms in the U.S. and Canada.

• Vote: 114–18 – passed – I voted Yes

# **Treatment and Accessibilities Committee**

Agenda E. Review revision of the Conference-approved flyer "Where Do I Go from Here?":

• Committee recommended updating the pamphlet including one additional change.

• Vote: 109–29 — passed – I voted Yes

## Grapevine / La Viña Committee

Agenda F. Consider a request to revise the pamphlet "Grapevine and La Viña: Our Meetings in Print" (PAI 79). The committee recommended that the pamphlet "Grapevine and La Viña:Our Meetings in Print" (P-52) be revised to clarify the text and accurately reflect changes in Grapevine operations. Passed

• Vote: 131–3 — passed – I voted Yes

New Business. AA Grapevine Survey

The committee recommended that the Grapevine Board obtain feedback from the Fellowship by conducting a survey of the membership to identify relevance, usefulness and financial viability

of products and services provided by Grapevine, such as the magazine, books (print, digital, and audio), podcast and social media (Instagram and YouTube), with a progress report to be brought back to the 2026 Conference Committee on AA Grapevine and La Viña, and a final report be provided to the 2027 committee.

The committee will provide a memo to the Board with suggestions for the content of the survey within 60 days.

• Vote: 123 –12 — passed – I voted Yes

#### **Floor Actions**

The committees are not the only source of recommendations for the body to consider and vote on.

During the general sessions, members may make recommendations directly from the floor that may not have passed through a particular Conference committee. These are known as floor actions.

#### Floor Action #1

It was recommended that:

The 75th General Service Conference issue a censure, expressing formal disapproval of past behavior by the General Service Board, for the following reasons:

- Contributing to an environment that led to the resignation of experienced and trusted Board members
- Ineffective, inconsistent, and non-transparent communication with the Conference
- Unacceptable behavior by trustees, including harassment, intimidation, and bullying
- Undermining the spiritual handshake with the Conference, as described in Concept VI, by not following a Conference Advisory Action

Accordingly, the Conference directs the General Service Board to:

- Continue to take its inventory, with specific focus on improving accountability to the Conference
- Report to the Conference on inventory findings and the specific actions taken to address these concerns

The Chairs of the Conference recused themselves and the entire General Service Board from voting, but stated that they still have a voice in the room.

A motion to decline to hear the censure motion was made, seconded, and voted on. The motion to decline to hear did not pass.

The censure motion will be heard. We had a thoughtful three hour conversation about the board's past deeds. Some comments regarding the effect a censure could have on our Class A Trustees. The behavior is years old and much of the board has now rotated. Are we being punitive? There was a motion to call the question and the chair declined in favor of continuing the conversation. Until everyone who wanted to be heard was heard, including me.

• Vote: 6 –108 — failed – I voted No

## Floor Action #11

or Action #11Begin a study to explore the needs of Spanish-speaking members for tools to access the Big Book. This study will include identifying specific needs within the Spanish speaking community to determine whether a plain language translation of the Big Book is an appropriate tool or if other accessible materials would be more effective to support Spanishspeaking members who face barriers related to literacy or comprehension. The 4<sup>th</sup> Edition of the Spanish Big Book is still in committee and the Spanish speaking community prefers to wait until it is released before a Plain Language version can be translated. In the meantime, this recommendation is looking for help for the Spanish speaking community.

• Vote: 106 –21 — passed – I voted Yes

# **Summary and Concluding Remarks**

The Conference ended with farewells from a few of our rotating Trustees, including Sister Judith and Marita. I was touched by their humility, grace through their selfless service to Alcoholics Anonymous. Marita was inspiring and I am grateful to have shared my first Conference with her.
