C. **Archives Liaison** (Alfredo M.) – From Heather L. - On December 18th Pete and I met up with Monique, our newest volunteer, at the Las Vegas Central Office. Monique and I met at the Las Vegas Roundup, where she expressed interest in learning more about the history of AA and Area 42. Pete and I unloaded and organized all the boxes that we had taken to the Las Vegas Roundup. On December 20th Susan, from District 8, and I met virtually. We had a great discussion about group histories. There was some discussion about autonomy in the submission or style that the group history may be written. If you look through many of the group history binders you will find that some are typed, some hand written on lined paper, and most use the group history form, which has changed a few times over the years. Susan may even create another form to encourage more participation, which she will share. However the group shares, we hope it is a reflection of who they are and how they began. Other ways to encourage more submissions might include: allowing groups to share their history at a meeting, a competition (maybe within the district), filling them out as a whole group exercise...what are your thoughts?

E. **Grapevine/La Vina Liaison** (April S) - Good morning everyone, I'm April, your Grapevine rep. The AA Grapevine is our meeting in print and an important tool of recovery. It reaches alcoholics who may be isolated, homebound, hospitalized, or unable to get to meetings, and it helps carry the message far beyond these rooms.

Current issue spotlight:

January's issue is "*Stories for Day Counters*," focused on what helped members most in their earliest days of sobriety—an excellent resource for newcomers and sponsors.

The **Grapevine Podcast** continues weekly, and the **AA Grapevine app** is available on Apple and Android, putting stories and recovery tools right on your phone.

They're also always looking for story submissions—on Sponsorship, Loneliness, Remote Communities, Steps, Traditions, and even jokes.

I really need help spreading the word about how important and how extremely helpful the Grapevine is, so if you're interested in supporting Grapevine at your group or want more info, please reach out to me as soon as possible. Thanks for letting me be of service.

F. **Hotline Liaison** (Open position) – No report

G. **PI** (Carol H) - Our objective is to reach the still suffering alcoholic through publicly facing channels. The phrase "attraction rather than promotion" (T11) refers to self-promotion, not publicity for our fellowship. The FCC no longer requires or allows PSAs for free, so they require payments for our PSAs. Occasionally, the media will air PSAs for free but usually they are approved due to personal connections. We would appreciate help from anyone that has connections in the media. If you do have connections, please reach out to me. We will ensure that your anonymity is protected. As well, the treatment industry has flooded the airwaves and social media with paid ads and personal promotion at a level we can't even hope to match. Last year, 2025, we were able to maximize our impact through a tri-fold flyer design with QR codes and websites in it. This was a significant savings in comparison to when we were distributing Big Books and 12 & 12s to the various facilities. To date, we have distributed more than 5,000 tri-fold flyers and have had thousands of hits on those codes. Assistance is needed to ensure that hospital emergency rooms, libraries, and other facilities remain adequately supplied with the tri-fold materials, in both English and Spanish versions. We are looking for volunteers that live near facilities to do this. All it takes is to stop by every few weeks or so, and to check on them – 10-to-15-minute commitment. We have had ads on Metro Las Vegas area buses since June and anticipate participating in that program again this year albeit at a reduced level due to budget constraints. We also need folks that wish to help with our social media sites. If anyone is interested in taking a small or more involved commitment, we would love to have you join us. In the meantime, if you need anything or have any questions related to Public Information, please do not hesitate to contact me, or John L., Chair of the SAGSC PI Committee.
