We currently have \$163.00 in cash on hand. On February 28th the savings account balance was \$2,000.28. G. **PI** (Carol H) - The Public Information Committee is currently seeking members who have connections — or know someone with connections — to any media outlets. This includes television, radio, advertising agencies, movie theaters, or other promotional platforms. Rather than cold-calling media facilities, we are hoping to secure personal introductions or appointments. Our goal is to present who we are and who we are not, what we do and do not do, and to offer short video clips or public service announcements (PSAs). We are exploring opportunities such as:

- Movie theater pre-show spots
- Radio stations
- Local television, i.e., late-night placements
- Other community media outlets

With recent budget cuts, we are working carefully within our means. After reviewing expenses, we made the difficult decision to eliminate bus advertisements. Although we had negotiated a good rate, it was not sustainable long-term. We are focusing more heavily on literature distribution, as pamphlets appear to reach farther and be more cost-effective. Current outreach goals include: Gaining access to the Clark County School District (we may have a potential contact through a school administrator in the coming month). Upcoming goals include distributing pamphlets to:

- Police stations
- Retirement communities
- Urgent care centers

Additionally, we are seeking a volunteer to chair or coordinate our Outreach Committee. This position would include:

- Organizing information tables at local events
- Coordinating community gatherings and outreach efforts
- Collaborating with other PI members
- Visiting districts to explain who we are and what we do.

J. **Intergroup Liaison** (Tina Y) - The Central Office says hotline positions are available, please contact Eileen for days and times. There were approximately 230 calls for February with 9 of them being 12 step calls. The Sale items this month are: Grapevine greeting card sets of 4 for \$7 and AA in prison for \$2.00. The board of directors says individual contributions were higher than expected, but group contributions were lower than expected. However, monthly expenditures are on track with everyone sticking to their budgets. It is urged that all the fellowship visit the Central Office for your literature purchases, as the Central office has the best prices in town. And a reminder to submit contributions using the Zelle account lvaa@lvcentraloffice.org. 12 step list has 63 people on the list and are doing well. The board of directors' chair says that a proposal was made that an additional finance committee be formed to keep an eye on all finances. After much discussion, the proposal was not approved. Due to #1, all financial and tax information is open and available to any member who wants to review it at central office, with the financial information being distributed every month during intergroup, and #2. The board of directors is operating in accordance with the bylaws which are also available to any member, and it was suggested that if anyone would like a copy of the bylaws, they should contact the Central Office to request a copy. It can be mailed or emailed to any member who requests a copy. They also received two continuations from an intergroup rep, Sara W. stating that she feels that the 501c3 state laws are not being followed by the board, and has indicated that she intends

to use her influence with the district attorney's office, Secretary of state, and other state offices and is prepared to initiate civil litigation against all of board members who served for the last 5 to 6 terms. And that she will use her influence within the SoS, Nevada Controller's Office and Treasury office to revoke the charter and nonprofit status. The Board had a lengthy discussion on these allegations. It has been determined that this IGR has threatened legal action. The Board has made the decision to be proactive, rather than reactive. and has allocated sufficient funding to retain an attorney for these matters. Founders' day has a new chair, Julie H. The Founder's Day lunch and history presentation will be Sunday, June 14th from 12-3 pm at Central Office. All of our contributions will go to the Central office. With a potluck and will provide a side dish. There will be amazing raffle baskets. The flyer will be out very soon. And are looking for raffle basket items. The date for the Gratitude ball will be September 19th at the new Westgate hotel. Although they have a few committee positions available, they had a great turnout for their business meeting and are looking for volunteers. Public information is generally in good shape; the literature subcommittee has 56 facilities engaged with brochure holders and is growing. And will be starting their social media promotion shortly. Volunteer positions are available. Silver Streak states that all budgetary and financial reports are listed each month in the current issue. New business, In the Guidelines, on page 11, Section 23 d) reads as follows: "The acceptance of bequests from any source or donations from any outside source is prohibited." The reality of the issue is that we are allowed and have been accepting bequests from AA members for quite some time, a maximum of \$10,000, a limit that has been set by GSO in NY. The Board proposes a simple fix with the addition of the word "outside" for the amended passage to read: "The acceptance of bequests from any outside source or donations from any outside source is prohibited."
