III. **Treasurer's Report** (Danielle T) - Morning all, my name is Danielle, I'm an alcoholic and I'm your treasurer. On March 1st we started out with a balance of \$6,161.15. We received contributions totaling \$910.45. We spent some money in March. We paid for the DCM to go to PRASSA, Zoom, rent for the workshop that is at the end of this month, and a check was returned to us, for a total of \$1,782.45, leaving us with a balance of \$5,289.15 at the end of the month in the checking account. We currently have \$291.00 in cash on hand. I'll be making a deposit of some of that this month. On March 31st the savings account balance was \$2,000.29. G. **PI** (Carol H) - Good morning everyone, my name is Carol and I am an alcoholic. Anne, D17 out of Ely, has been phenomenal in her productivity for the PI Committee. She's reached out to the staff at the Tonopah Times and Pahrump Valley Times and they said they will start running classified ads in both the print and online editions with the 24 hotline and LV Central Office website information. She also had an opportunity during the assembly on Sunday (4/12/26) to meet with the Tonopah City Manager and she will be bringing him some Big Books, information on what AA is and what AA is not, along with a local Tonopah meeting schedule, as well as information about how to find AA in any community. Three city managers are also part of the effort to bring a health clinic to Tonopah so he is in the process of hiring clinicians for a soon to be opened health clinic in Tonopah. I believe that it is linked with the same health clinic that is in Sandy Valley as well as Pahrump, so there'll be a huge triangle of information getting out there. I've already supplied our pamphlets to the Sandy Valley office. In addition, out in White Pine and Lincoln Counties, they continue to see our classified ads in every published paper and on the digital editions of their papers. The radio station in Eastern Nevada also runs a PSA. On a more local note, we've been recruiting for roles that have not been filled yet, notably in the media subcommittee, although recently we've had some success in that area. One being a resource that has extensive media experience becoming involved in connecting to the media. We also have a friend of AA with extensive media connections that has begun press release distributions. And two, a new social media chair that is taking on the management of our Instagram and Facebook

accounts. But there is always a need for more volunteers. The more help, the better, right? So if you're interested in volunteering as part of a PI subcommittee, you do not have to attend the monthly meeting. If that's what's holding you back. I. **Accessibilities Liaison** (Ruthie B) - When I put my hand up to act as a liaison for this committee, I admit there was a deeply personal reason for this. I had a paraplegic cousin who worked on the committee to pass the ADA Act. The Americans with Disabilities Act (ADA) was signed into law on July 26, 1990, to act as a comprehensive civil rights law prohibiting discrimination against individuals with disabilities. It was created to ensure equal opportunity, full participation, independent living, and economic self-sufficiency for people with disabilities, leveling the playing field in employment, transportation, public accommodations, and state/local government services. This means making sure the hand of A.A. is actually reachable for every alcoholic, regardless of vision, hearing, mobility, neurodivergence, learning differences, or life circumstances. We understand that there are many who may not realize how welcome they would be in bringing their questions and challenging situations to our committee. We are here to listen and to work together on addressing the important issue of "who's missing in the rooms of Alcoholics Anonymous and why?" Your insights and experiences are indispensable in helping us create a welcoming and supportive environment for everyone. That spirit is at the heart of an upcoming **hybrid workshop** our committee is hosting called *Our Shared Journey: Voices on Unity and Recovery*. This workshop is designed to help us slow down and truly listen. We'll hear directly from sober alcoholics who navigate our Fellowship with visual impairments, dyslexia, and neurodivergence. They'll share what it's really like to walk into a meeting, read our literature, follow a speaker, or take on service commitments when the world—and sometimes our rooms—aren't built with them in mind. We'll also hear from guest sponsors who will talk about walking the Three Legacies with sponsee's who face access barriers— Marita R. and Greg M. The workshop will be held **Sunday, June 28th, from 1:00 to 3:00 PM Pacific Time**, both in person at the Las Vegas Central Office and online via Zoom, so people can participate in the way that works best for them. Everyone is

welcome—especially anyone who has questions, lived experience, or a curiosity about who might be missing from our rooms and why.
